Purchase a Roadside Mowing & Brushing Tractor

1. Staff Recommendation: Resolution ☑ Direction □ Information □ THAT the Council of the Township of Drummond/North Elmsley accepts the bid from Elliott Farm Equipment Ltd. to purchase a Roadside Mowing & Brushing Tractor for \$168,182.53 (plus applicable taxes). And;

THAT the Council of the Township of Drummond/North Elmsley approves that the additional funding required over the existing 2017 Budget funding of \$130,000 will come from the Equipment Reserve.

2. Purpose:

The purpose is to replace the existing 2007 roadside mowing tractor with a larger roadside mowing/brushing tractor.

3. Background:

Township currently owns a 2007 Kubota tractor c/w sickle mower for roadside mowing. With the rapid growth of small brush and the ongoing threat of Wild Parsnip, staff feels that a larger mowing tractor and brushing head would allow us to maintain our roadside growth proactively by having a larger reach heavier cutting capabilities. This purchase will help keep our fleet in good condition and stay compliant with our current Asset Management Plan. The purchase of this piece of equipment was approved within the "2017 Capital Budget" at an estimated cost of \$130,000.

4. Discussion:

Staff advertised the Equipment RFP within the local newspaper and on the Township's web-site. Four equipment suppliers picked up documents and were given two weeks to review. On Wednesday December 13th 2017 at 2:00pm local time, four proposals were received. All four proposals were scored on the following:

Cost Factor............40 points Equipment Specs......30 points Warranty & Service.....20 points Integration with Fleet...10 points

As all companies met the requirements and practically scored the same on, *Equipment Specs.*, *Warranty & Service* and *Integration with Fleet*. The deciding influence came down to *Cost Factor*.

Below are the bid prices received: (less applicable taxes)

Elliott's (Massy Ferguson)....\$162,375 Hartington's (Kubota)......\$171,100 Green Tech (John Deere).....\$173,117 Smith's (New Holland).......\$186,620

Elliott's also provided us an option to upgrade to a "Votec" flail mower for an additional \$5,807 which would increase their bid to \$168,182 and still keep them at low bid for the tender for our consideration.

5. Financial:

The purchase of this piece of equipment was approved within the "2017 Capital Budget" for \$130,000. Based on the above noted bid prices the existing funding falls short of the current bids. Therefore, staff is recommending that the balance of the funding come from the Equipment Reserve to cover the outstanding balance of Elliott's bid. The Equipment Reserve currently has \$280,890 in it which is sufficient enough to cover the additional costs.

6. Summary:

Staff recommends that Council accepts the bid from Elliott Farm Equipment Ltd. to purchase a *Massy Ferguson* tractor, *Diamond* brushing arm and a *Votec* flail mower for \$168,182 (plus applicable taxes).

THE COMMITTEE OF THE WHOLE RECOMMENDS that Council approve that onethird of the remuneration paid to the elected members of Council continue to be considered as expenses incident to the discharge of their duties as members of Council or a local board as per the provisions of subsection 283(7) of the *Municipal Act*, 2001

AND FURTHERMORE that staff be directed to bring a by-law forward for passage.

2. PURPOSE:

The purpose of this report is to review the one-third tax allowance benefit for Members of Council for the term of Council 2014-2018.

3. BACKGROUND:

The *Municipal Act* allows municipalities to remove the one-third tax free portion included in the remuneration paid to Members of Council. Each term, Council must review the continuation of the one-third tax free provision and decide whether to maintain the tax free status or convert their remuneration to 100% taxable. Once Council elects to eliminate this provision, it becomes effective in the subsequent year, and future Councils cannot revert back to the tax free allowance.

4. DISCUSSION:

Under current tax legislation, one-third of a councillor's total remuneration can be excluded from income (tax free). Total remuneration consists of salaries and honorariums. For council members that pay into OMERS, 100% taxable income becomes pensionable service compared to only two-thirds of the pensionable service, if the one-third portion is non-taxable.

Since the change in legislation in 2001, each term, previous Councils have reviewed this option to maintain the one-third tax free portion of their remuneration. The current

Council is now required to review this provision and determine whether or not to retain the tax free provision.

It is recommended that the one-third tax free portion be maintained as there are no additional costs associated with this option.

FINANCIAL IMPLICATIONS:

None. There are no costs associated with maintaining the status quo.

THE CORPORATION OF THE TOWNSHIP OF DRUMMOND/NORTH ELMSLEY

BY-LAW NO. 2018-

COUNCIL 1/3rd INCIDENTAL EXPENSE BY-LAW

BEING A BY-LAW TO ESTABLISH THE ONE-THIRD OF COUNCIL REMUNERATION AS EXPENSES INCIDENT TO THE DISCHARGE OF COUNCIL DUTIES.

WHEREAS Section 283 (1) of the Municipal Act, 2001, 5.0. 2001, c. 25, as amended, permits a municipality to pay any part of the remuneration and expenses of the members of any local board of the municipality and of the officers and employees of the local board.

AND WHEREAS Section 283 (7) states a Council shall review a by-law under subsection (5) at a public meeting at least once during the four-year period corresponding to the term of office of its members after a regular election.

NOW THEREFORE, the Council of the Corporation of the Township of Drummond/North Elmsley hereby enacts as follows:

- THAT one-third of the remuneration paid to members of Council continues as expenses incident to the discharge of their duties as members of the Council.
- 2. THAT this by-law comes into force and effect on the day of its passing.
