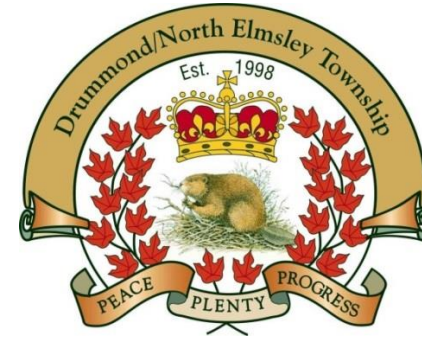

The Carleton Place Household Hazardous Waste Depot is a waste management facility licensed by the Ministry of the Environment (M.O.E.)

*We are licensed to accept materials from residents of Carleton Place, Mississippi Mills, Beckwith, Montague, Perth, **Drummond/North Elmsley**, and Smiths' Falls. You may be required to prove that you own property or reside in one of these municipalities.*

Be prepared to show identification.

HOUSEHOLD HAZARDOUS WASTE DEPOT

WASTE ITEMS MUST BE IDENTIFIABLE AND IN A SEALED CONTAINER OR PACKAGE.

NO EXCEPTIONS

WASTE ITEMS ACCEPTED

- FLOURESCENT LIGHT BULBS (*CFL's*) & FLOURESCENT TUBES (*48" and other*)
- MERCURY (*MERCURY FILLED THERMOMETERS, THERMOSTATS*)
- MOTOR OIL, ANTIFREEZE, OIL FILTERS
- FLAMMABLE LIQUIDS (*GASOLINE, SOLVENTS, STRIPPERS, TURPENTINE*)
- LATEX PAINT, OIL PAINT & STAIN
- ORGANIC FLAMMABLES (*ADHESIVES, DRIVEWAY SEALANT, CAULK, RESIN*)
- PROPANE CYLINDERS
- LEAD ACID VEHICLE BATTERIES OR DRY CELL BATTERIES
- AEROSOL CANS
- ACID OR BASE CORROSIVES (*CLEANERS, DRAIN OPENERS, RUST REMOVER*)
- PESTICIDES
- OXIDIZERS (*POOL CHEMICALS, FERTILIZER*)
- FIRE EXTINGUISHERS



WASTE ITEMS NOT ACCEPTED

The Province of Ontario mandates which materials we are legally allowed to accept and which ones we are not. We have compiled the following information to help residents find a legal and convenient method to dispose of materials that are not handled by our HHW Depot. This is not a complete listing but provides a guideline to help you find local merchants participating in 'take back' programs. Thank you for your continued efforts to eliminate hazardous products from our landfills.

AMMUNITION, EXPLOSIVES OR FLARES - Can be taken to any detachment of the Ontario Provincial Police. Go to their offices during regular business hours Monday - Friday.

ASBESTOS - The homeowner should never handle asbestos. Please call a licensed demolition expert.

OXYGEN, FREON OR ACETYLENE GAS – Most bottles will have the company name printed on the side that supplied the bottle. These companies will take them back.

PATHOLOGICAL WASTE (SYRINGES) - Take back to the drug store where purchased. Must be placed in a hard plastic container for safety reasons.

PHARMACEUTICALS (PRESCRIPTION OR NON PRESCRIPTION DRUGS FOR HUMAN OR VETERINARY USE) – Take back to the dispensing pharmacy or veterinary office for safe disposal.

P.C.B. CONTAMINATED WASTE (FLUORESCENT LIGHT BALLASTS) - Ballasts manufactured prior to 1980 could contain PCB's. After 1980 they do not contain PCB's but they contain oil and should not be disposed of in a landfill. The homeowner should never handle PCBs. Please call a licensed disposal expert.

RADIOACTIVE WASTE (SMOKE DETECTORS) - According to the Ontario Ministry of the Environment smoke detectors should be discarded with your regular household waste at the curb. Apparently the amount of radioactive waste contained in these units is negligible.

THIS FACILITY CANNOT BULK FLAMMABLE OR HIGHLY VAPOUROUS LIQUIDS, THEREFORE CONTAINERS HOLDING THESE LIQUIDS WILL NOT BE RETURNED. (E.g. gasoline containers.)
